MEMORIAL RESOLUTION

FOR

EDWARD P. POWERS



Edward P. Powers was born April 27, 1908, in Moulton, Iowa. He attended law school at the University of Missouri in Columbia. Judge Powers practiced law for many years with Hugh Guernsey in Centerville, Iowa, where he lived for 78 of his 89 years. Judge Powers served as city attorney for Centerville, Iowa, and as county attorney for Appanoose County. In 1963 he was appointed district judge in what was then the Second Judicial District. He retired in 1972.

Judge Powers married Etta Singley in 1931. Mrs. Powers survives, as does a daughter, Mary Tickle, of Arlington, Texas; seven grandchildren and eleven great-grand children. His son, Edward A. Powers, preceded him in death in June of 1997, as did his parents, three brothers and two sisters.

He was a veteran of World War II, having served in the navy in the South Pacific.

Judge Powers was very involved in the Masons and attained and served in many offices in the Mason organization. He served on the Rathbun Lake planning committee with the Corps of Engineers, was past commander of the National Guard in Centerville, and a member of the Centerville American Legion.

Judge Powers died March 6, 1998, at the Rowley Masonic Home in Perry, Iowa. Funeral and Masonic services were held at the First United Methodist Church in Centerville, Iowa. He is buried at the Sunset View Cemetery in Moulton, Iowa.

Judge Powers earned the respect of members of the bar who practiced before him, and the public that he served for so many years at the bar and on the bench. The State of Iowa is a better place for his life and his work.
